

Red Cloud Community Schools
Board Minutes

The Red Cloud Community Schools Board of Education held their regular monthly board meeting on Monday, April 15, 2024 in the Library at the Red Cloud Elementary School. President Armstrong called the meeting to order at 7:00 p.m. with members Armstrong, Hobbs, Horne, Ord, Peterson, and VanWey answering roll.

Mrs. Dallman, Elementary Principal, reported that there was an ESU 9 stakeholder Zoom meeting, the Preschool passed their Rule 11 Observation, the Science Fair was held, they performed a tornado drill, Spring Break was held, TIP Training at ESU 9 was held, Mr. Heldt and she have completed interviews for teaching positions, Kindergarten Roundup was held, there was a parent meeting for Title I, and NHS held an elementary game night. Upcoming events include NSCAS/MAPS Testing, Acadience Testing, Field Day on May 3, the Music Concert on April 25, and Honors Night on May 1.

Mr. Heldt, Secondary Principal, reported that NHS students helped with the Science Fair, 20 students participated in Actions Day at CCC in Hastings, Track and Golf and underway, CCC has talked to Sophomores and Juniors about being offered online college courses, Mrs. Sunday took students to Transitions Day at ESU 9, Mariah McDole competed in State Speech and placed 7th in the Extemporaneous category, Seniors participated in County Government Day, and the Bob Bohrer home golf meet was held with Lukas Armstrong finishing 1st, Gage Ely 8th, and the team 3rd overall. NHS completed their roadside pickup, Mrs. Ely took some students on a science med visit, NHS hosted an elementary game night, State Weightlifting was held at Harvard, Mrs. Burgess took Juniors to UNL for a visit, the Juniors took the ACT with several of them having high scores, and FFA attended State FFA. Upcoming events include track and golf meets, Honors Night, and Graduation on May 11.

Superintendent Hof gave updates on the HVAC progress at the Elementary, the wrestling/weight building at the high school, and some legislative bill status. He also did a raffle drawing for a Beef Boosters fundraiser.

Ord moved to approve the agenda. Hobbs seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Horne moved to approve the minutes from the March 18, 2024 regular board meeting as presented. VanWey seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Hobbs moved to approve payment of the District 2 claims and all regularly occurring bills. Peterson seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Armstrong moved to accept the financial reports as presented. Horne seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Committee Reports included Armstrong thanking the Teachers' Association's willingness to change due dates for contracts in the past that has helped with finding new staff on behalf of the Negotiations Committee, and on behalf of the Facility Committee Hobbs announced the walkthrough after last meeting went well.

Peterson moved to approve all of the teaching contracts presented. Hobbs seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Horne moved to accept the resignation from Josh Sholtz. Armstrong seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Armstrong moved to approve the Superintendent as the authorized representative for Title I and Federal Programs. Ord seconded the motion. Motion carried 6-0 by roll call vote.

The next regular monthly meeting will be held on Monday, May 20, 2024 at 7:00 p.m. in the Library at Red Cloud Elementary. There being no further business, Mr. Armstrong declared the meeting adjourned at 7:42 p.m.
