

Red Cloud Community Schools
Board Minutes

The Red Cloud Community Schools Board of Education held their regular monthly board meeting on Monday, October 16, 2023 in the Library at the Red Cloud Elementary School. President Armstrong called the meeting to order at 7:01 p.m. with members Armstrong, Hobbs, Horne, Ord, Peterson, and VanWey answering roll.

Mrs. Dallman, Elementary Principal, reported that Parent Teacher Conferences were held and had 93% attendance at the Elementary. 4th and 5th Grade students went to Bladen for UNL Animal Science Day. 4th Grade students went to Hastings for Fitness Day. Moms and Muffins was held for Preschool with 100% attendance. Continuous Improvement and 504 meetings were held at ESU9. NDE put on a SPED Strategies meeting meant to help raise scores for students. Fire Prevention week was held with multiple firemen coming to the school to show students fire trucks and equipment. Upcoming activities include a Teaching and Learning Conference in Hastings and an Autism Conference and Dyslexia State Reporting to be held online.

Mrs. Dallman read Secondary Principal, Mr. Heldt's report. He reported Juniors took the ASVAB and are going to have scores gone over on October 19th. Parent Teacher Conferences were also held at the High School with good attendance. District Land Judging and Range Judging were held. Mrs. Sunday took 9 students to SPED Transition Day in Hastings. Mr. Heldt was on the external evaluation team for Silver Lake Schools. Mrs. Burgess wants to start a Lifeline Preventions meeting for parents. One Act went to UNK to observe a performance. Junior High Fall Sports have concluded with football and volleyball doing well. William Rasser placed 25th at District Cross Country. High School volleyball placed 4th at TVC. Upcoming activities include District volleyball and a teacher in-service at Adams Central on October 23rd.

Superintendent Hof thanked South Central State Bank for sponsoring the Wilcox-Hildreth High School Football game. He also gave an update on the hail damage that took place. He is waiting on insurance for more information.

Horne moved to approve the agenda. Hobbs seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Ord moved to approve the minutes from the September 18, 2023 regular board meeting and budget hearing & tax request as presented. VanWey seconded the motion. For—Armstrong, Hobbs, Ord, Peterson, VanWey; Abstain—Horne. Motion carried 5-0-1.

Armstrong moved to approve payment of the District 2 claims. Peterson seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Horne moved to accept the financial reports as presented. Armstrong seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

Ord moved to approve opening a Construction Account within the Activity Fund. Horne seconded the motion. All voted in favor. Motion carried 6-0 by roll call vote.

The Board set a date of November 14th at 11 a.m. at the Scout Lodge for a Board Retreat to discuss policies.
